My staff and I have thoroughly enjoyed the opportunity to connect with those farmers and ranchers who invest their dollars into the checkoff at various meetings and conventions.

Thank you for your continued participation in the beef checkoff. As calendar year 2012 comes to a close and we reflect back on the year, it's hard to select only a few program highlights to share because there were so many. Minnesota Beef Council is responsible for investing your beef checkoff dollars to build beef demand through promotion, research and education. We are pleased to share with you the enclosed state & national beef checkoff annual report for fiscal year 2012, highlighting our successful programs and a report of expenditures.

The beef checkoff program is celebrating its 25th year of continued success! But as we ring in the New Year we also face challenges as an industry and as a checkoff program. At their 2013 Outlook & Strategies Seminar, CattleFax stated that they expect the US cattle inventory to be 89.8 million head on Jan. 1, 2013, down over 1 million head (1.1 percent) from a year ago.

That means in 2013, your checkoff will once again be doing more with less.

We all have a role in the beef checkoff and we appreciate your cooperation in remitting the dollars due from private treaty sales. Enclosed is a copy of the private treaty remittance form. Agricultural Literacy Beef Books Are Here!

Minnesota authors Susan Anderson and JoAnne Buggey have written several books in a series about various agriculture commodities. Awesome Agriculture books are dedicated to teaching agricultural literacy to young children. These books explain to children the importance of farming and its relationship to the food they eat.

"Awesome Agriculture: Beef Cattle an A to Z Book" – This book introduces beef cattle and beef to children in preschool through early elementary. The book utilizes a child's developing alphabet and reading skills to teach the basics of agricultural literacy.

"Beef Cattle in the Story of Agriculture" – This book is for children in the older elementary grades. In this book, children first learn where and how beef cattle are raised. Then they learn how these cattle are turned into the beef products that provide an important part of their diet. Plus, they discover how non-edible beef by-products show up in everyday objects.
